## My Construction Team



- Took over team on 30 March 2020 have met them face to face as a team once!
- Team made up of 7 trained Inspectors & 2 trainees. Currently no Visiting Officers. This equates to 8.8 FTE [Will lose 2 Inspectors during 2021]
- 4 fatal accidents across patch since April 2020
  - 3 x roofing FFH & 1 x trench collapse
- Work made up of:
  - Asbestos Inspections, Cladding Inspections, COVID Inspections, Health Campaign, F10 visits, Training Visits, Concern Investigations & RIDDOR Investigations

## **My Construction Team**



- Very heavy reactive workload at present. Up to the end of December 2020 (Last years figures for same period in brackets where applicable):
  - 258 (62) Complaint investigations handled
  - 42 (62) RIDDOR investigations handled
  - 116 COVID Checks
  - 168 (157) Construction Inspections
  - 34 (34) Prohibition Notices issued
  - 24 (20) Improvement Notices issued



## **Kent FOD Group**



- Again a heavy reactive workload at present. Up to the end of December 2020 (Last years figures for same period in brackets where applicable):
  - 164 (14) Complaint investigations handled
  - 45 (34) RIDDOR investigations handled
  - 280 COVID checks
  - 47 (199) Inspections
  - 28 (12) Prohibition Notices issued
  - 23 (58) Improvement Notices issued





# **Guidance for Crown Prosecutors Interim COVID Reviews**



- Guidance issued in April 2020 to assist Crown prosecutors
- Review current cases and any new cases in light of interim guidance
- Review to consider if still in the public interest to put a case through the Court system. Would a caution be suitable?
- Personally reviewed 10 (already approved) cases all in the public interest to remain in the Court system
- Guidance in place until CPS remove it

# **Construction Team Prosecutions Heard**



- 2 Prosecution cases heard since April 2020 [Major backlog due to pandemic]
  - Axio (Special Works) Limited [Overturned concrete pump injuring worker]
    - £20,000 Fine, £5,285.70 Costs
  - Mark Bucknall (Director) [8m FFH when installing skylight]
    - £1,760 Fine, £2,000 Costs contribution
  - Fines being reduced due to economic "hit" of COVID-19
  - Some cases being heard virtually
  - Many more CD cases in the pipeline:
    - 3 x GNM & H&S Cases awaiting trial in 2021(CPS leading)
    - 1 x H&S case awaiting trial in November 2021
    - 2 x H&S cases awaiting trial dates TBC
    - 2 x H&S cases awaiting sentencing
    - 3 x H&S cases awaiting first hearings

  - HSE COVID Guidance











### 828,000


Workers suffering from workrelated stress, depression or anxiety (new or long-standing) in 2019/20

### 347,000

Workers suffering from a new case of work-related stress, depression or anxiety in 2019/20

### **17.9** million

Working days lost due to work-related stress, depression or anxiety in 2019/20



The rate of self-reported work-related stress, depression or anxiety has increased in recent years.

Working days lost per worker due to self-reported workrelated stress, depression or anxiety shows no clear trend.

Workload, lack of support, violence, threats or bullying and changes at work are estimated to be the main causes of work-related stress, depression or anxiety based on 2009/10-2011/12 LFS data.

- develop jointly agreed, practical solutions to help manage and prevent these stressors.



Health and safety at work Summary statistics for Great Britain 2020





Industries with ill health rates statistically significantly higher than the rate for all industries were public administration and defence, human health and social work and education.

Agriculture, forestry and fishing, construction, accommodation and food service activities, manufacturing and wholesale and retail trade (including motor vehicle repair) had statistically significantly higher injury rates than for all industries.




# EU Referendum – 23 June 2016 Withdrawal – 31 January 2020 (23:00hrs) Transition – 31 December 2020 UK on own with trade agreement – 1 January 2021





NB – Separate Rules/Systems in place for Northern Ireland



Through the transition period it was "Business as Usual" as nothing changed

Biocides, Plant Protection Products, REACH, CLP, Product Safety: Systems changed on 1 January 2021 (By law at 23:00hrs on 31 December 2020)

- The <u>Explosives Regulations 2014 (as amended)</u> state that economic operators must not place, or make available, civil explosives on the market unless they conform with certain requirements, including meeting the essential safety requirements, conformity attestation against the relevant tests and correct application of the UKCA mark.
